- I warrant that I have authority to authorise the surrender and sale or disposal of the animal.
- I relinquish all ownership rights in the animal.
- In consideration of Council accepting the surrender of, and selling or otherwise disposing of, the animal:-

- (a) I release Council from any claim which I may have against Council in connection with the surrender and sale or disposal of the animal except if , and to the extent that, the Claim arises because of Council's negligence or default; and
- (b) I will indemnify and keep Council indemnified against all claims against Council as a consequence of the surrender and sale or disposal of the animal except if, and to the extent that, the Claim arises because of Council's negligence or default.

In this paragraph 5:-

- (a) "Claim" includes a claim, demand, remedy, suit, injury, damage, loss, Cost, liability, action, proceeding or right of action; and
- (b) "Cost" means a cost, charge, expense or other expenditure of any nature; and
- (c) "Council" includes, where relevant, each authorised person of Council and Council's employees, agents and contractors.

6. This request to accept the surrender of, and procure the sale or disposal of, the animal is irrevocable.

7. **Surrender Fee:** 2015/2016 financial year

- a. Dogs – One hundred and twenty dollars (\$120.00) or Ten Dollars (\$10) each pup under 12 weeks of age;
- b. Cats – Sixty dollars (\$60.00) – or Ten Dollars (\$10) each kitten under 12 weeks of age;
